Proposed Bylaw Changes

ARTICLE VI BOARD OF DIRECTORS

Current Article

Two (2) BMX Committee positions will be open for election in odd numbered years, and one (1) BMX Committee position will be open for election in even numbered years

Revised Article

Three (3) BMX Committee positions will be open for election in odd numbered years, and two (2) BMX Committee position will be open for election in even numbered years

Rationale

BMX has grown and needs bigger representation from the community on the Committee. A bigger committee makes sure all the different voices have an opportunity to be heard.
