f) Apart from reasonable expenses, the Board of Directors will not be paid.

Chief Commissaire's Report – Geordie Ma

The 2015 racing season has zipped by at a startling pace. I find myself awed that it is already the fall when I seemed like it was just a short time before that we were planning the racing season in Red Deer with white snow on the ground. It has been a pleasure being a part of the growing and expanding bicycle racing scene in Alberta.

This past year marked several highlights on the officiating side of our organization:

The year started off with the execution of a National MTB Commissaire course in Calgary, AB in early March. We had the opportunity to place several of our commissaires in this course and set them off on their path to become National Commissiares. Join me in congratulating Carolyn Croft, Steve Baker, Adrienne Mae, Felix Lee, Vitaly Rudenko and Robert Armstrong in successfully completing the classroom portion of their qualification.

We held entry level commissaire courses in all three disciplines (Road, MTB, and BMX). Attendance at these courses was great across all disciplines. However, enrollment was down from last year. I would ask all members of the ABA to work to identify commissaire candidates (either themselves or others) and encourage them to take a course in the spring. I certainly hope that we can continue to nurture these new commissaires and help them along in their development.

We held our fourth "Chief Commissaire Summit" which once again proved to be a highly valuable gathering of some of our more senior commissaires in the province. This meeting gave us an opportunity to review changes in the UCI / CCC / ABA rulebooks and discuss an officiating standard that was to be implemented across the province. Many thanks to Loyal Ma and Andy Holmwood who successfully lead the summit in my absence.

The Tour of Alberta offered up many commissaire development opportunities that allowed us to expose several commissaires to the inner workings of an international caliber event. Andy Holmwood and Michael Pinkoski, who were assigned to the UCI commissaires panel were joined by Robert Armstrong and Meredith Plant who were assigned as provincial assistants to the panel.

The creativity of our provincial race organizers expanding into fat bike and gravel bike races allowed our excellent provincial commissaires to rise up to the challenge of a new event and contribute to the successful execution of these new event formats.

If given the opportunity, I look forward to continuing the great strides we have made in commissairing development next year. There is still much to do, and we must focus our efforts on aiding all of our commissaires in improving their competencies and achieving the designations that they are striving for. Our ever expanding racing calendar has placed some strains on the availability of our A Level commissaires. However, I am pleased to see that in the past year the pool of commissaires we had to draw from allowed us to fill assignments with significantly less last minute changes. I believe it may be the early indications that our recruiting efforts are paying off. However, our focus in the coming years must be to increase our recruiting efforts to bring more officials into the support and, more importantly, mentor and train our existing commissaires to take on ever more responsibility. I hope that we help our commissaires in the province find their dedication to the sport of cycling to be both rewarding and enjoyable.

VP BMX—Darren Wililams

It has been a busy year for BMX in Alberta. As in any year prior to an Olympics, BMX programs at the world level start to ramp up for qualification purposes and that effect often trickles right down the Provincial level.

In 2015 we had two team Alberta riders make the National Team as Juniors with an eye on the future. Those riders were Deven Kawa (junior male) and Daina Tuchscherer (junior female). Both riders had an impressive showing at the world championships in Zolder, with Daina finishing 5th in the time trials and making the semis in class. Deven finished 48th in time trials and just missed semis with a 5th in his quarter.

On home soil Daina claimed the National Championship and Canada Cup titles and took a 5th in the semi at the Pan Am Games racing against the Elite women. Deven took a tough 7th at Nationals and 3rd overall in the Canada Cup Series.

On the amateur (challenge) side we had two fast up and coming ladies bring home world plates from Zolder even after some tough luck with crashes and unclipping. Avriana Hebert brought home a W8 and Cayleigh Vanstaaldenuin took a W6.

Closer to home, BMX in Alberta continues to grow and shine with another stellar Provincial Cup Series in 2015. Overall BMX license numbers are up just slightly but the Series saw its best year to date. More riders are starting to explore the competitive side of racing.

The provincial team had a great year under the management and coaching of Kristen Kawa and Wendy Vandenhoven (with the help of Penny Peacock). A trip to the supercross Hill in Abbotsford helped prepare the team for what racing at the elite level has become and what will be required to make the National Team. After that, a trip to Nationals proved fruitful with 8 podium finishes, and 4 titles out of 14 team members attending.

There were some growing pains with the introduction of a new Junior Development class (mirroring what is happening with the Canada Cup Series), but things are being ironed out and it's a great addition to racing on a developmental level.

Of course we can't forget the three day UCI C1 level races held in Calgary. These brought out some heavy hitters from the international stage chasing country points for 2016 Rio qualifying. It was one of many outstanding BMX weekends this past summer.

With the National Championships coming to Calgary in both 2016 and 2017, and some incredible talent coming up in all ages look for more big things with BMX in Alberta.

Lastly, I would like to thank the BMX Committee and the Alberta Bicycle Association staff for an awesome year. It's been great working with you but alas, I have found I'm not a politician. In a democracy it's always the majority that rules but I've found the minority is always the most vocal. I hate that I can't make everyone happy all the time and in the end, I just want to ride my bike.

Alberta is a great province to be a bike racer! Most recently, four Alberta athletes (Sidney McGill, Michael van den Ham, Mark McCoonnell, & Aaron Schooler) participated in the Cyclocross World Cup in Las Vegas, which is the first time the World Cup has been hosted outside Europe. Sidney McGill had a great ride, finishing 33rd overall and 4th Canadian, all while being the youngest rider in the race.

Alberta was down a few races this year for a multitude of reasons, but the races that we did have were well run and well attended. With a few holes in the calendar, we had some people step up and organized new events, particularly the Ghost of the Gravel race in Calgary and the abundance of track races. The spring series races in Edmonton continued to successfully kicked off the early season and continued with into the summer.

It is often disheartening to see such a barren calendar at the beginning of the year, but a time of fallow can be just what is needed to rejuvenate long-time organizers and spur on new organizers to step. I can also personally attest that organizing races can bring great joy and that the ABA is on your side every step of the way. We encourage people to step up and try it out. If that seems daunting, why not pair up with an experienced organizer to learn the ropes.

Youth participation in cycling is continuing to grow in Alberta. The Trailblazers youth races continued to be successful in 2015. LAMP and Sprockids programs continue to fill up early and have waiting lists. In cyclocross we have seen more youth participating in the midweek series' and at the Alberta Cup races.

The Learn to Race clinic that was developed last year expanded significantly this year, with 67 people participating through the year. The Racing Committee decided to offer upgrade points for those who participated. Even if that was the only reason that people participated, we still saw an increase in people learning and improving their skills. Safety continues to be a priority for the racing committee; maintaining our first aid standards at races, continuing to enforce and follow the rules of the road, and improving knowledge and skills for everyone.

Early season cyclocross races are attracting massive fields with multiple days having over 200 participants, including more than 45+ women.


VP Recreation & Transportation Report – Karly Coleman

Independent Auditor's Report

To the Members of the Alberta Bicycle Association

I have audited the financial statements of the Alberta Bicycle Association as at December 31, 2014 which include the Statement of Financial Position and the Statements of Operations, Changes in Net Assets, Cash Flows, and a summary of significant accounting policies and other explanatory notes for the year ended December 31, 2013.

Management's Responsibility

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as management determines necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Canadian auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

Basis for Qualified Opinion

In common with many not-for-profit organizations, the Alberta Bicycle Association derives revenue from certain fundraising activities, the completeness of which is not subject to satisfactory audit verification. Accordingly, my verification of these revenues was limited to the amounts recorded in the records of the Alberta Bicycle Association and I was not able to determine whether any adjustments might be necessary to revenue, excess of revenue over expenses, assets and net assets.

The Alberta Bicycle Association have recorded an accrual for a liability relating to Goods and Services Tax although they are not registered to collect this tax. This amount is an estimate, the completeness of which is a material uncertainty.

Qualified Opinion

In my opinion, except for the effects of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself of the completeness of fundraising activities and the completeness of the estimate of tax payable, these financial statements present fairly, in all material respects, the financial position of the Alberta Bicycle Association as at December 31, 2014 and the results of its operations and cash flows for the year ended December 31, 2014 in accordance with Canadian accounting standards for not-for-profit organizations.

1. NATURE OF THE ORGANIZATION

The Alberta Bicycle Association ("ABA") was incorporated under the Societies Act of Alberta on February 27, 1973 as a not-for-profit organization. The ABA is exempt from income tax under section 149 (I) of the Income Tax Act.

Its mission is to act as the organizing body which promotes all aspects of cycling in Alberta.

2. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared according to Canadian accounting standards for not-for-profit organizations of which the most significant policies are:

(a) Basis of Accounting

Management has concluded that the going concern basis of accounting is appropriate for the ABA.

(b) Revenue Recognition

The ABA follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized when received or receivable if the amount to be received can reasonably estimated and collection is reasonably assured.

(c) Cash and Cash Equivalents

Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investing or other purposes. For an investment to qualify as a cash equivalent it must be readily convertible to a known amount of cash and be subject to an insignificant risk of changes in value. Therefore, an investment normally qualifies as a cash equivalent only when it has a short maturity of, say, three months or less from the date of acquisition.

(d) Inventory

Inventory consists of provincial team clothing and medals. It is recorded at the lower of cost and net realizable value. Cost is calculated using the first in, first out method.

(e) Capital Assets

Capital assets are recorded at cost. Amortization is recorded on a straight-line basis over their estimated useful lives as follows:

Office and Computer Equipment	3 years
Software	3 years
Race Trailer	10 years
Timing Equipment	3 years

(f) Deferred Capital Contributions

Restricted revenue that has been used to fund purchases of a capital nature is deferred and is recognized as revenue on the same basis as the related asset is amortized.

(g) Contributed Goods and Services

Contributed services and donated items are recognized in the financial statements when the fair value can reasonable be estimated, when the services are used in the normal course of the ABA's operations and would otherwise have been purchased.

A number of volunteers have made significant contributions of their time to the ABA. The value of this contributed time is not reflected in these financial statements.

(h) Use of Estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect amounts reported in financial statements and accompanying notes. These estimates are based on management's best knowledge of current events and actions that the ABA may undertake in the future.



Independent Auditor's Report

To the Members of the Alberta Bicycle Association

I have audited the financial statements of the Alberta Bicycle Association as at December 31, 2014 which include the Statement of Financial Position and the Statements of Operations, Changes in Net Assets, Cash Flows, and a summary of significant accounting policies and other explanatory notes for the year ended December 31, 2013.

Management's Responsibility

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as management determines necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's responsibility

Accordingly, my verification of these revenues was limited to the amounts recorded in the records of the Alberta Bicycle Association and I was not able to determine whether any adjustments might be necessary to revenue, excess of revenue over expenses, assets and net assets.

The Alberta Bicycle Association have recorded an accrual for a liability relating to Goods and Services Tax although they are not registered to collect this tax. This amount is an estimate, the completeness of which is a material uncertainty.

Qualified Opinion

In my opinion, except for the effects of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself of the completeness of fundraising activities and the completeness of the estimate of tax payable, these financial statements present fairly, in all material respects, the financial position of the Alberta Bicycle Association as at December 31, 2014 and the results of its operations and cash flows for the year ended December 31, 2014 in accordance with Canadian accounting standards for not-for-profit organizations.

It is management's opinion that the Association is not exposed to significant, currency, price, market or credit risks arising from these financial instruments. The Association may be exposed to significant interest risk relating to a Canada Revenue Agency determination.

Certain of the prior year figures have been reclassified to conform to the current year presentation.

10. RELATED PARTY TRANSACTIONS

At certain times, board members act as cycling officials. They are paid according to the standard official rate schedule.
