President's Report - 2012 Andy Holmwood

The ABA continues in 2012 along a path of renewal started in 2010. Continuity of staff and board members, complemented by key additions to both, contributed to progress in many areas.

Goals established at the outset of 2012 included: review of policy, support of Recreation and Transportation initiatives, an improved and enhanced commissaire program, and growth in participation amongst other things. Progress toward some of these goals is being met, while in other areas we continue to be challenged.

Several key initiatives were undertaken by the board in 2012, one of which was policy review. This task is comprised of inventorying and reviewing the Association's policies, looking in particular for redundancy, contradiction, relevance, and improvement. While still at a relatively early stage in this process, significant work has been completed, including a new medical support policy now in effect at ABA events.

Other areas in which progress was achieved over the past year included supporting Recreation and Transportation initiatives, with several R&T members attending the Velo-city conference in Vancouver. Also, the commissaire program was renewed by way of review of provincial regulations in three sports, in addition to a refreshed uniform.

In broad terms, several performance measures of the Association were achieved over the past year. Financial goals for 2011 included a significant surplus, which was realized. Meanwhile, membership numbers continue to remain strong. The staffing situation continues to evolve – the hiring of Philippe Abbot in the role Provincial Head Coach in addition to the return of Josh Peacock from his Olympic Games sabbatical will hopefully signal the start of a lengthy period of stability.

Looking forward, 2013 has several important challenges: Our reporting methods to the Alberta Sport Foundation will change – one component of which will be the presentation of a new strategic plan in March of next year. The ABA board will look to engage the membership in this process toward the end of this year. In addition, we continue to be challenged in capturing all cycling events occurring in the province. Finally, 2013 will see Team Alberta in action at the Canada Games, where we hope to show off a reinvigorated Provincial Team program.

The successes listed above would not be possible without the devoted efforts of Executive Director Heather Lothian, complemented by Sport Coordinators Gillian Millet, Krystyn Ong, and Josh Peacock. I would also like to thank the board, in addition to members of our three standing committees, for their considerable volunteer efforts in keeping the ABA running.



Vice President BMX Shane Peterson

The 2012 season of bmx had us once again moving in the right direction for increased and improved development of the sport in Alberta and Canada. We continued to see our development program for top tier athletes solidify through our provincial team. Our provincial race series remains the example in Canada that other provinces are enviously working toward. 2012 was the first season of a multi year agreement with the Olds Ag Society for indoor bmx racing in Alberta operated by a sub-committee of Alberta BMX that is known as Alberta Indoor Cycling Centre (AICC). As well this was the first year for a pilot project that became dubbed the BMX Flophouse. A private venture that allowed high performance Alberta BMX riders the chance to live, attend online school, train and race in San Diego for the months of Feb, Mar, and April of 2012.

The 2012 season is most likely to be remembered by most as a season of injuries. Racing started and finished with a notably higher-than-average rate of injury to our Junior and Elite athletes. Jim Brown, Alberta's only fully carded National Team Athlete crashed while using the BMX Flophouse as his base in the early spring, and he, as well as two other Team Alberta riders at the flophouse, never did fully recover even by the end of the season from their injuries. At the last World Cup of the season in Abbotsford Sept 15, Sabrina Millman of Cochrane, the top Elite woman in Canada, sustained a very serious injury and is still in hospital in Abbotsford in the intensive care unit. Numerous other Jr and Elite riders failed to complete the season due to injury. It was, and is, an unprecedented season.

2012 was the inaugural season of the BMX Canada Cup, the first truly national BMX series in Canada. It was not without its challenges for the first year, but with refinement it could develop into an excellent tool for rider development and talent identification for Cycling Canada. I can only hope that the riders and clubs (regardless of sanction) across Canada see the value in it, and that Cycling Canada continues the series.

While BMX's overall licensee numbers in Alberta were down slightly (3.07%) this year, ridership in the AB Cup series continues to be consistent. Rider licensee numbers overall declined somewhat, but most of that decline was in a dramatic de-

cline in General memberships. This decline was nearly all replaced in UCI license sales, as most riders who previously rode on the General shifted to UCI. The clubs were experiencing difficulty with riders racing at multiple facilities on the General licences when they were intended for home track only, therefore promoting the General license was reduced at some tracks.

In 2011 we were able to send John Philips and Carolyn Croft to ON for the National Level BMX course. In 2012 they were able to complete their practical exams at the Canada Cup in St. Albert. This made Carolyn Croft the first female National BMX Commissaire in Canada.

Looking forward, the winter season is set to begin soon at the indoor facility in Olds. With indoor spanning all the winter months this year it will include a separate winter race series that will be open provincially to all riders. The Olds Agriculture Society is eager to work together with AICC to expand what was started last year. The Olds Town Council is very happy that cycling is making a commitment to the community and they are keen to work with the Ag Society and AICC to ensure its success. The longer



season in coming years should help with ongoing provincial team programs and overall rider development. I highly encourage the mountain bike riders of Alberta to take advantage of this facility in Olds.

In 2013 we will be having the National Championships back in Alberta either at St Albert or Calgary BMX.

A number of things that were reported at last year's AGM to be initiatives for 2012 had to be 're-prioritized' when items like the indoor, a larger than usual provincial team, the San Diego training facility, and the new Supercross facility came into play and evolved quickly forcing a diversion of attention. So that leaves 2013 with a regrouping and re-focussing on things like getting all of the Alberta club coaches on track with the NCCP, getting the Provincial Team more SX training time etc, etc.

Vice President Racing Adrienne Tibbitts

As 2012 winds down – unless you are a kindred 'cross fiend – we find time to reflect a little on a great season of riding and racing that went by far too fast.

A big policy change, allowing the females of Alberta to race through the same type of categories of our male racers, moved away from the two women's categories of years past. The hope for this change broadens the range of categories for women to race in and move their way up the ranks, competing with others more evenly matched. Currently, women's participation is looking good, with the larger percentage participation coming from XC and cyclocross. As always, more females racing is our goal!

Speaking of fast females, Alberta had the joy of watching one of its own taste a delicious victory this year. Tara Whitten had a great showing at the London Olympics, winning bronze in the Women's Team Pursuit on the track and finishing fourth in the Omnium, while Monique Sullivan finished 6th in Kieran. An amazing and inspiring moment in Alberta cycling, especially for the girls!

At the Paralympics we had two Albertans racing for Canada. Both Jaye Milley and Brayden McDougall were selected to compete in the road event and did Alberta proud.

We are always looking at a way to grow our fields and keep the sport alive in the province. With the addition of Philippe Abbott as our Provincial Head Coach, we will be seeing our development team head to some exciting camps this winter and in 2013. We anticipate seeing some great action in the upcoming season.

Mountain bike racing is alive and well, a lucky thirteen races rolling out with well over two thousand participants. Unfortunately, Alberta only saw two Downhill events take place. Despite this low, the participation was still strong. It is excellent to see some the young talent taking over the scene. The changes allowing U13 riders to join the ranks rolled out successfully, with a good handful of them out to play in Grande Prairie.

Recreation and Transportation Committee Report

The majority of the Recreation and Transportation Committee went to the VeloCity Global 2012 this year in Vancouver. It was a marvelous opportunity to meet with other cycling advocates from around the world, hear other issues from other communities, or hear the same issues from other communities and their take on solving that issue. With the remainder of the R&T budget we purchased an annual subscription for our committee members to have access to the Association of Pedestrian and Bicycle Planners. Access to this group will continue the contact with many of the groups we encountered at the conference. It is recommended that the R&T Committee members be sent to additional conferences as the funding and timing allows, and that the membership to the APBP webinars is continued.



In other news, the committee has been working with the Province of Alberta, discussing regional tourism initiatives and how that might incorporate cycling. Early in November the R&T committee plan to have a survey up so that our members can elabourate on the types of cycling in their area. Prior to the conference there was a contingent of Canadian advocacy cyclists who met to discuss starting a Canadian Advocacy group, and this initiative is underway. The R&T committee is participating as things progress. The likely name of organization is 'Canada Bikes'. It's purpose is to share information, work towards national funding, legislation, coordinated education programs. An initial focus is 'safe trucks' with sidebars to prevent bicyclist run-over incidents. We have also made forays into articulating a bicycle friendly province/city/business program, similar to that which the League of American Bicyclists has, as well as keeping our hand in with trail development in Alberta through our connections with Alberta Trailnet.

Other initiatives:

Alberta Motor Association 1. – 'Bike Assist' program launched 1 June 2012. Deliver air for flat tires, put on a chain that have come off, tighten loose parts (handlebars, pedals, etc) or make minor adjustments and transport the member and their bicycle home or to a repair facility in the event of broken or non-working parts. Alberta Motor Association 2. – The AMA and most major municipalities' Transportation Departments are meeting in hopes of setting up a formal "Made-in-Alberta" plan to incorporate cyclists into traffic planning and better educate cyclists and drivers. Independent Auditor's Report

To the Members of the Alberta Bicycle Association

I have audited the financial statements of the Alberta Bicycle Association as at December 31, 2011 which include the Statement of Financial Position and the Statements of Operations, Changes in Net Assets, Cash Flows, and a summary of significant accounting policies and other explanatory notes for the year then ended.

Management's Responsibility

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian generally accepted accounting principles and for such internal control as management determines necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

Basis for Qualified Opinion

In common with many not for profit organizations, the Alberta Bicycle Association derives revenue from certain fund raising activities, the completeness of which is not subject to satisfactory audit verification. Accordingly, my verification of these revenues was limited to the amounts recorded in the records of the Alberta Bicycle Association and I was not able to determine whether any adjustments might be necessary to revenue, excess of revenue over expenses, assets and net assets.

Qualified Opinion

In my opinion, except for the effects of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself of the completeness of fundraising activities, these financial statements present fairly, in all material respects, the financial position of the Alberta Bicycle Association as at December 31, 2011 and the results of its operations and cash flows for the year then ended in accordance with Canadian generally accepted accounting principles.

1. NATURE OF THE ORGANIZATION

The Alberta Bicycle Association ("the ABA") was incorporated under the Societies Act of Alberta on February 27, 1973 as a not for profit organization. The ABA is exempt from income tax under section 149 (I) of the Income Tax Act.

Its mission is to act as the organizing body which promotes all aspects of cycling in Alberta.

2. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared in accordance with Canadian generally accepted accounting principles for not for profit associations. The significant accounting policies are as follows:

(a) Revenue Recognition

The ABA follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized when received or receivable if the amount to be received can reasonably estimated and collection is reasonably assured.

(b) Inventory

Inventory consists of provincial team clothing and medals. It is recorded at the lower of cost and net realizable value. Cost is calculated using the first in, first out method.

(c) Property and Equipment

Property and equipment are recorded at cost. Amortization is provided on a straight line basis over their estimated useful lives as follows:

Office and Computer Equipment 3 years
Software 3 years
Race Trailer 10 years
Timing Equipment 3 years

(d) Deferred Capital Contributions

Restricted revenue that has been used to fund puchases of a capital nature is deferred and is recognized as revenue on the same basis as the related asset is amortized.

(e) Contributed Goods and Services

Contributed services and donated items are recognized in the financial statements when the fair value can reasonable be estimated, when the services are used in the normal course of the ABA's operations and would otherwise have been purchased.

A number of volunteers have made significant contributions of their time to the ABA. The value of this contributed time is not reflected in these financial statements.

(f) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect amounts reported in financial statements and accompanying notes. These estimates are based on management's best knowledge of current events and actions that the ABA may undertake in the future.

(g) Financial Instruments

The ABA applies Sections 3855 "Financial Instruments – Recognition and Measurement", and 3861 "Financial Instruments – Disclosure and Presentation" of the Canadian Institute of Chartered Accountants (CICA) Handbook. As permitted by the CICA, the ABA has elected not to adopt the new standards 3862 and 3863, and continues to apply Section 3861 on disclosure and presentation of the financial statements.

10. FINANCIAL INSTRUMENTS

Under the standards for recognizing and measuring financial instruments, all financial assets are classified into one of the following four categories: held for trading, held to maturity, loans and receivables or available for sale. All financial liabilities are classified into one of the following two categories: held for trading or other financial liabilities.

The ABA's financial assets and financial liabilities are classified and measured as follows:

Held for trading

Cash and short-term investments are designated as held for trading at fair value with any subsequent changes in fair value as a charge to the statement of operations.

Loans and receivables

Accounts receivable are recorded at amortized cost less any impairment losses recognized and approximate their fair values due to the relatively short periods to maturity.

Other financial liabilities

Accounts payable and accrued liabilities are recorded at amortized cost and approximate their fair values due to the relatively short periods to maturity.

Other amounts noted on the Statement of Financial Position are not financial instruments.

The ABA has not entered into any derivative transactions. In addition, the ABA's contractual arrangements do not have any embedded features.

It is management's opinion, that the ABA is not exposed to significant interest, currency, price or credit risks arising from these financial instruments.
